BACKGROUND

PURPOSE OF THE CALL

The Innovation Cluster is calling for the submission of Funding Proposals from a wide range of stakeholders engaged in activities that falls within the animal health innovation value chain. These include Science Councils, Higher Education Institutions, Small and Medium sized Enterprises and large companies.

The Innovation Cluster will consider Funding Proposals that focus in the following areas:

- · Enabling technologies
- Diagnostic technologies
- · Vaccine technologies
- Small molecule Pharmaceuticals
- · Phyto and ethno-veterinary medicine

EVALUATION CRITERIA AND PROCESS

In addition to other criteria outlined in the TIA website, submissions need to meet the following criteria:

- 1. All applications submitted must be on the Funding Proposal template, available on the TIA website www.tia.org.za.
- 2. All proposals must demonstrate the use of animal health technologies that are new or can be further improved and exploited in South Africa and/ or in collaboration with international partners.
- Proposals that demonstrate an attractive business case with the potential to create considerable socio-economic value for South Africa, such as but not limited to job creation, GDP growth, skills transfer, solutions to national priorities impacting both small scale and emerging farmers.
- 4. Proposals must be based on animal health technologies whose time to market is not more than four (4) years
- 5. The stage of technology being developed must be proof of concept or beyond.

EXCLUSION CRITERIA

The Innovation Cluster reserves the rights not to consider Funding Proposals:

- That are not related to the advancement of in animal health technologies
- · That seeks to promote tobacco, liquor, recreational drugs, gambling or sex trade markets
- Where the application is not from a South African legal entity
- · Where the Funding Proposal template is not completely populated and the declaration section is not signed
- · Where the stage of development is basic research
